

Privacy Policy

1. INTRODUCTION

We take your privacy very seriously and are committed to protecting the privacy of all visitors and subscribers to our website www.docrypto.com (the "Website") or any application we make available via an app store (the "Application", together with the Website, the "Platform"), and the corresponding services available through the Platform (the "Services").

This Privacy Policy (the "Policy") forms a part of the Terms of Use relating to the use of the Website, and by using the Website you expressly consent to our collection, use and disclosure of your information in accordance with the terms of this Policy. We may amend this Policy at any time without notice, and such amendments become effective from the date upon which we make them available on the Website. If you do not agree to the Policy (including any amendments), then you should immediately cease using the Website.

Please read this privacy policy carefully as it contains important information on who we are and how we collect, store, use and share your information. By accessing the Platform or using our Services or otherwise indicating your consent, you agree to, and where required, consent to the collection, use and transfer of your information as set out in this policy. If you do not accept the terms of this policy, you must not use the Platform and/or the Services. This privacy policy supplements other notices and privacy policies and is not intended to override them.

If any term of this Policy is or may become for any reason invalid or unenforceable at law, the validity and enforceability of the remainder will not be affected.

2. YOUR INFORMATION

The type of information we collect from you is either personal to you, or is general in nature:

Information you provide to us. You can provide us with information about you by filling in forms on our website or by contacting us by telephone, email or otherwise. The information you provide to us may include your name, address, email address, telephone number and any other information you choose to provide.

Information we collect about you. When you use our website, we automatically collect information about you, your computer or mobile device, your IP address and information about how you use our website and other websites.

Information we receive from other sources. We may receive information about you if you use a property portal website to contact us. This could include details of your property search and information about your likely interests. We may combine this information with other information you provide to us or which we collect about you.

3. COLLECTING AND USING INFORMATION

We use personal information about you for the following purposes:

Providing services to you. We use your personal information to provide you with information and services

that you request from us and to administer any promotions or competitions you enter with us.

Marketing and advertising. We use your personal information to provide you, or to permit selected third parties to provide you, with information about goods or services that we think will interest you.

Service improvements. We may use your personal information to tell you about changes to our services and to help keep our website secure.

The legal basis for processing your personal information in these ways is typically one of the following:

Performance of a contract. It is necessary for us to process your personal information to perform a contract with you, or for us to take steps on your instruction prior to entering into a contract with you.

Legitimate interests. It is in our legitimate interests to use your personal information for this purpose to operate our website, to provide and promote our services, and to protect our business.

Legal obligations. It is necessary for us to process your personal information to comply with the law.

We use General Information to help us make the Website more useful to customers (including to help us assess content of interest to visitors), and for other purposes such as determining the Website's technical design specifications and identifying system performance or problem areas, for tracking activity on the Website, preparing reports, assessing trends, and otherwise monitoring the way in which the Website is being used none of which would be in a way that personally identifies any users.

4. DISCLOSURE OF PERSONAL INFORMATION

We may share your Personal Information in connection with the purposes above with third parties in the following circumstances:

Landlords, tenants, vendors and purchasers. When you ask us to do so, we may share your personal information with current or prospective landlords, tenants, vendors and purchasers (and their respective advisors) in relation to any potential sale or rental. If any of these third parties is a business, then they will become a data controller of the information we provide, and their own privacy policies will apply.

To our third-party service providers. We partner with and are supported by service providers around the world. Our third-party service providers are not permitted to share or use personal information we make available to them for any other purpose than to provide services to us.

We may also share your personal information with third parties in order to obtain professional advice, or to comply with a legal obligation or a request from law enforcement or another regulatory authority.

5. SECURITY

We have implemented security policies, rules and technical measures to protect the personal data that we have under our control from unauthorised access, improper use and disclosure, unauthorised destruction or accidental loss.

Keeping your Personal Information secure and preventing unauthorized access is of utmost priority to us, and we take all steps reasonably necessary to protect your Personal Information against any unauthorised access, use, alteration, disclosure or destruction. Whilst we have put in place physical, electronic and managerial procedures to secure and safeguard your Personal Information, we will not be held responsible for any unauthorised access by third parties and we cannot guarantee that the Personal Information provided by you or that is transmitted via this Website or by e-mail is totally secure and safe.

6. COLLECTION YOUR PERSONAL DATA

The information that we collect from you may be transferred to and stored in a country outside the country in which the DoCrypto is located, for who's website you have accessed in order for the information to be collected. It may also be processed by staff operating outside such country, who work for us or for one of our suppliers. By submitting your information, you agree to this transfer, storage, and/or processing. We will take all steps reasonably necessary to ensure that your data is treated in accordance with this Policy.

Only the data essential and pertinent to our interactions with you are gathered by us. The aforementioned data will be retained for as long as it is necessary for the purpose for which it was obtained and/or as long as it is required by law. Any personal data whose retention is no longer permitted by law will be immediately destroyed or disposed of securely.

We might not be able to offer you our services if you decide to revoke your consent for the collection, use, and processing of personal information.

7. YOUR RIGHT TO ACCESS AND CORRECT YOUR PERSONAL INFORMATION

We respect your right to access and control your information, and we will respond to requests for information and, where applicable, will correct, amend, or delete your personal information. Any such request can be made to support@docrypto.com.

Access to personal information: If you request access to your personal information, we will gladly comply, subject to any relevant legal requirements and exemptions, including identity verification procedures. Before providing data to you, we will ask for proof of identity and sufficient information about your interaction with us so that we can locate any relevant data. 10. DISCLOSURE OF INFORMATION

We undertake not to provide your personal information to third parties save in accordance with this policy.

Your information will not be disclosed to government or local authorities or other government institutions save as required by law or other binding regulations.

11. USER RESPONSIBILITY
